The Tony Quinn Memorial Competition is governed by the rules of the S.O.B.H.D. Age groups will be determined according to number of entrants prior to the competition date. Medals are awarded to six places. First Place and Runner Up Trophies will be awarded in each category except Primary.

Prize Money for oldest age group: \$30 \$25 \$20 \$15 \$10 \$5 Trophies no medals will be awarded. All competitors must show a valid ScotDance or FUSTA card in order to compete. Dancers must dance in numerical sequence or be disqualified.

The decision of a Judge is Final. No correspondence or discussion can be entered into between a Judge or competitor or parent or legal guardian. Dancers must remain in appropriate costume for the awards ceremony.

Pre-Premier registration at 8.00 a.m. Competition begins at 8.30.m. with the Fling. Intermediate and Premier dancers should be prepared to dance at 1:30 p.m. with the Barracks. The Tony Quinn Memorial Trophy - Dance off for the 2nd Place Premier winners of the Village Maid.
